

Declaration in accordance with REACH Regulation EG Nr. 1907/2006 on the Registration, Evaluation, Authorization and Restriction of Chemical Substances

The European REACH Regulation (Registration, Evaluation and Authorization of Chemicals) has been in force since June 1, 2007. REACH primarily applies to manufacturer, importers and dealers of chemical products, but under certain circumstances also affects companies using chemical substances in the broadest sense.

The Provertha GmbH is a downstream user for the purposes of the EU Regulation because we are neither an importer nor a dealer of chemical products. The chemicals we use in our production (e.g. lubricants and greases) do not reach the lower threshold of 1 ton per annum under any circumstances. PROVERTHA is neither obliged as per the EU Regulation to register nor to create material safety data sheets.

We are pursuing the implementation of the REACH regulation at our suppliers in the interests of a high product safety and have asked them to inform us immediately according to the obligation to provide information from the REACH Regulation, should now or future substances classified by ECHA according to the candidate list With more than 0.1% by mass in the product.

Many of our products contain a substance from the current list of candidates

Concentrations of more than 0.1 mass percent:

Lead, CAS number 7439-92-1, EC number 231-100-4

Danger: lead is toxic to reproduction in accordance with Art. 57c REACH.

Lead is not released when system components are used as intended, but can be released when used improperly or during disposal

PROVERTHA is aware of the duty to communicate information according to REACH article 33 and will fulfill it, if it becomes necessary due to new findings or a change of the SVHC list.
